

CLYDE CITY COUNCIL
Special Session - Reorganization of Council
January 7, 2025

Clyde City Council held a special session at 6:30 p.m. on January 7, 2025 in Council Chambers of the Municipal Building, 222 N. Main Street, Clyde, Ohio for the sole purpose of holding the reorganization meeting. City Solicitor Zachary Selvey called the meeting to order.

SETTING SALARIES OF COUNCIL

It was noted the current salaries are at the maximum amount allowed per the Charter. Council members could vote to lower the amount, but not to raise it.

Motion: to maintain the salary for Council at its current rate, **Action:** Approve,
Moved by Council Member Chris Shay, **Seconded by** Council Member Greg McMaster.

Vote: Motion carried by unanimous roll call vote (**summary:** Yes = 5).

SETTING SALARY OF MAYOR

Mr. Selvey stated the rate as set by Council would go into effect immediately for 2025. It was clarified that this rate is not set by a Charter provision. The Vice Mayor salary follows the Mayor's salary, and the Vice Mayor only receives this portion of the Mayor's salary if the Vice Mayor runs a meeting. The 2024 Mayor salary is \$4,000 and the amount can be set, without limitations, by Council.

Motion: to maintain the salary for Mayor at \$4,000/annually as it was in 2024, **Action:** Approve,
Moved by Council Member Doug McCauley, **Seconded by** Council Member Chris Shay.

Vote: Motion carried by unanimous roll call vote (**summary:** Yes = 5).

Yes: Council Member Chris Shay, Council Member Scott Black, Council Member Greg McMaster, Council Member Terri Meek, Council Member Doug McCauley.

The Vice Mayor's salary is set by Ordinance. No vote is necessary.

ELECTION OF MAYOR

Mr. Selvey opened the floor for nominations for Mayor. Council members voiced no reason for change of this position.

Motion: to nominate Doug McCauley for Mayor, **Action:** Nominate,

Moved by Council Member Chris Shay, **Seconded by** Council Member Terri Meek.

Vote: Motion carried by unanimous roll call vote (**summary:** Yes = 4-0-1).

Yes: Council Member Scott Black, Council Member Greg McMaster, Council Member Terri Meek, Council Member Chris Shay.

Abstain: Council Member Doug McCauley

Doug McCauley elected as Mayor of Clyde for 2025.

ELECTION OF VICE MAYOR

Mr. Selvey opened the floor for nominations for Vice Mayor. Council members appreciate Mr. Black's experience and see no reason for change of this position.

Motion: to nominate Scott Black for Vice Mayor, **Action:** Nominate,

Moved by Mayor Doug McCauley, **Seconded by** Council Member Greg McMaster.

Vote: Motion carried by unanimous roll call vote (**summary:** Yes = 5-0).

Yes: Council Member Greg McMaster, Council Member Terri Meek, Mayor Doug McCauley, Council Member Scott Black, Council Member Chris Shay.

Scott Black elected Vice Mayor of Clyde for the year 2025.

ASSIGNMENT OF COUNCIL SEATS

Mr. Selvey explained that Council is required by the Charter to either agree to assignment of Council seats, or to draw names for Council seats. All members agreed to keep their same seats as in 2024.

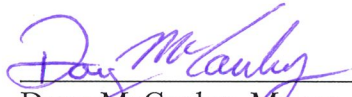

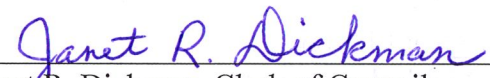
